The Abstract and Full paper must be accompanied by a cover page stating the title of the paper, theme/sub-theme, name of the author(s), designation, course and year of study, institution affiliated, postal address with contact details. The Abstract and Full paper has to be submitted only in MS-Word either in English (Times New Roman) or in Tamil (Bamini). The abstract should not exceed 300 words typed in 1.5 line spacing with 5 key words.

The full paper should contain between 3500 and 4500 words – including footnotes. The main text of the full paper should be in Times New Roman for English and Bamini for Tamil with a font size of 12 pt., 14-pt. heading and double line spacing. The footnote should be in Times New Roman or Bamini with a font size of 10 pt. and single line spacing. The Indian Law Institute (ILI) Rules of footnoting must be adopted. One-inch margin should be maintained on all sides.

About the Directorate of Legal studies:

The Directorate of Legal Studies was established in the year 1953 with the primary objective of improving the standard of legal education in the State of Tamil Nadu. About the Government Law College Madurai

To cater the demands of the southern districts of Tamil Nadu, the Government decided to establish a Law college at Madurai and it started functioning in the additional building of the Madurai Kamaraj University from the academic year 1974-75, and later it was shifted to the present location at Dr. Thangaraj Salai K.K. Nagar, Madurai and functioning since 1980-81. The college was previously affiliated with the Madurai Kamaraj University and presently affiliated with the Tamil Nadu Dr. Ambedkar Law University, Chennai, since 1997-98. The college offers 3-year LL.B. Degree Course and 5-year B.A., LL.B. Degree course and 2-year LL.M. Degree courses in Property Law and International Law and Justice. The college has been included under Sec. 2(f) of the U.G.C. Act, 1956 and declared fit to receive central assistance under Sec. 12(B) of the U.G.C. Act, 1956. To satisfy the need of present generation of students and to boost the infrastructure, a new building exclusively for library and auditorium with A.C. facility has been inaugurated in Feb. 2021. To upgrade the infrastructure to the present needs of students a new building (G+3) with hi- tech facility and state of art infrastructure is on the anvil.

- Right to Speech and Expression.
- Right to form peaceful assembly and association.

- Right to Information.
- Rights of an accused.
- Rights of a prisoner.
- Right to access justice through constitutional courts and Human Rights Court.
- The role of National and State Human Rights Commission(s)/NGOs in the protection of Human Rights.

The above-mentioned sub-themes are not exhaustive. The author can select relevant topics in nexus with main theme.

CALL FOR PAPERS:

We are looking forward to a well-researched unpublished paper without plagiarism (both English and Tamil) from Academicians, policymakers, journalists, representatives of Government Organisations, Civil Society/NGOs, Lawyers, Research Scholars, and Students. The proposal in the form of Abstract (not exceeding 300 words) on identified themes and sub-themes shall reach through e-mail at least by **28th November 2022**. The full paper (between 3500 and 4500 words – including footnotes) shall reach through e-mail at least by **05th December 2022**. Co-authorship up to the maximum of 2 authors is allowed but has to remit the fee separately. All abstracts and full papers in MS-Word shall be sent to the e-mail address: **glcmdusem@gmail.com**.
